CRC(NZ) Food Grade Synthetic Gear Grease	For poly-alpha-olefins (PAOs): PAOs are highly branched, isoparaffinic chemicals produced by oligomerisation of 1-octene, 1-decene and/or 1-dodecene. The crude polyalphaolefin mixture is then distilled into appropriate product fractions to meet specific viscosity specifications and hydrogenated. In existing data, there appears to be no data to show that these structural analogs cause health effects. In addition, there is evidence in the literature that alkanes with 30 or more carbon atoms are unlikely to be absorbed when given by mouth.
